**WILLCOX LIVESTOCK AUCTION IS ONCE AGAIN GEARING UP FOR OUR ANNUAL BULL SALE. WLA HAS BEEN SERVING THE SOUTHWEST FOR NEARLY FIFTY YEARS AND WE ARE HAPPY TO KEEP THE TRADITION GOING. WITH YOUR PARTICIPATION, WE ARE EXPECTING TO HAVE A GREAT BULL SALE THIS YEAR!**

**AGAIN THIS YEAR THE ENTRY FEE IS \$60.00. AS WE DID LAST YEAR, THE EXTRA \$10.00 DOLLARS WILL BE GOING TO THE OWNER OF THE GRAND CHAMPION BULL AND THE OWNER OF THE RESERVE CHAMPION BULL SPLIT 60%/40% RESPECTIVELY AS AN ADDED INCENTIVE. THE TROPHIES THIS YEAR WILL BE BELT BUCKLES AND WE WILL CONTINUE TO TRY AND MAKE THIS EVENT THE BEST SALE IN THE SOUTHWEST.**

**SALE WILL BE LIMITED TO A TOTAL OF 30 HEAD OF BULLS. PREFERENCE FOR CONSIGNMENTS WILL BE GIVEN TO FORMER CONSIGNERS AND BREEDS THAT ARE NOT ADEQUATELY REPRESENTED. ENTRIES WILL NOT BE CONSIDERED COMPLETE OR VALID UNTIL THEY ARE IN THE OFFICE.**

**THE NUMBER OF BULLS FROM EACH CONSIGNOR OR OPERATION WILL BE LIMITED **TO THREE (3) HEAD.** IF 30 ENTRIES ARE NOT RECEIVED BY THE ENTRY DEADLINE, ADDITIONAL ENTRIES FROM A CONSIGNOR WILL BE CONSIDERED. **THIS INCLUDES ENTRIES FROM IMMEDIATE FAMILY OPERATIONS AS WELL. 1. DATE OF SALE: THURSDAY, MARCH 28, 2024 AT 12:00 PM.
2. DATE OF SIFTING AND GRADING: TUESDAY MARCH 26, 2024 AT 9:00 A.M.
3. ARRIVAL DATE: ALL BULLS MUST BE IN THE YARD BY 5:00 P.M. MONDAY, MARCH 25.
4. ENTRY FEES & SELLING COMMISSION: AN ENTRY FEE OF \$60.00 PER HEAD PLUS A COMMISSION OF **5% ON THE GROSS** SALE WILL BE CHARGED EACH CONSIGNOR. THE ENTRY FEE IS TO ACCOMPANY ENTRY FORM

NO REFUNDS OF ENTRY FEE. IF A BULL IS SIFTED BY MANAGEMENT OR THE GRADING COMMITTEE, YOUR ENTRY FEE IS FORFEITED.

5. ENTRY DEADLINE: OPEN UNTIL SALE IS FILLED. ONLY HAND DELIVERED OR MAILED ENTRIES WILL BE ACCEPTED. **PLEASE NO PHONE ENTRIES! ENTRIES WILL ONLY BE CONSIDERED VALID IF SUBMITTED TO THE WILLCOX LIVESTOCK AUCTION OFFICE AND ARE PAID IN FULL.**

REGISTERED BULLS WILL NOT BE CATALOGED WITHOUT COPIES OF REGISTRATION PAPERS.

6. THE NUMBER OF BULLS FROM EACH CONSIGNOR OR OPERATION WILL BE LIMITED TO THREE (3) HEAD. IF 30 ENTRIES ARE NOT RECEIVED BY THE ENTRY DEADLINE, ADDITIONAL ENTRIES FROM A CONSIGNOR WILL BE CONSIDERED. THIS INCLUDES FAMILY OPERATIONS WHERE AN IMMEDIATE FAMILY MEMBER HAS CATTLE AS PART OF THE SAME OPERATION. WE ARE TRYING TO GIVE CONSIGNORS A FAIR CHANCE TO PARTICIPATE IN THE BULL SALE.

7. **SALE WILL BE LIMITED TO A TOTAL OF 30 HEAD OF BULLS. ANY OTHERS WILL BE PLACED ON A WAITING LIST. PREFERENCE FOR CONSIGNMENTS WILL BE GIVEN TO FORMER CONSIGNERS AND BREEDS THAT ARE NOT ADEQUATELY REPRESENTED.**

6. MINIMUM AGE: THERE IS NOT A SPECIFIED MINIMUM AGE, HOWEVER, ALL BULLS MUST PASS SEMEN AND BREEDING SOUNDNESS EXAM BY A LICENSED VETERINARIAN.

7. MAXIMUM AGE: THIRTY-SIX (36) MONTHS OF AGE.

8. SIZE AND QUALITY: BULLS SHOULD BE WELL GROWN OUT WITH PLENTY OF SIZE FOR AGE WITH GOOD BREED. BULLS SHOULD NOT BE EXCESSIVELY FAT BUT CARRYING ENOUGH CONDITION TO EXHIBIT THEIR GENETIC POTENTIAL OF PRODUCING FEEDER CATTLE THAT WILL RETURN A PROFIT TO ALL SEGMENTS OF THE INDUSTRY.

9. TATTOOS OR BRANDS: ALL TATTOOS AND IDENTIFICATION BRANDS MAY BE CHECKED AT THE SALE AND MUST CORRESPOND WITH THE REGISTRATION CERTIFICATES. PLEASE: ALL BULLS MUST HAVE SOME FORM OF LEGIBLE ID. THIS NUMBER MUST CORRESPOND WITH THE ID NUMBER USED ON THE HEALTH PAPERS.

10. HEALTH REQUIREMENTS:

A: IN STATE: ALL BULLS MUST BE SEMEN, AND TRICHOMONIASIS (PCR TEST) TESTED. ALL TESTS MUST BE MADE WITHIN 30 DAYS PRIOR TO SALE DATE. ALL TESTS MUST BE DONE BEFORE ARRIVAL.

**ABSOLUTELY NO TEST WILL BE MADE AT WLA!**

B: OUT OF STATE: ALL BULLS MUST BE SEMEN AND TRICHOMONIASIS (PCR) TESTED, PLUS AN ARIZONA PRIOR PERMIT MUST BE OBTAINED BEFORE ENTERING ARIZONA. FOR THIS PERMIT CALL: WEEKDAYS-(602) 542-4293. YOU MUST HAVE WHATEVER TEST IS REQUIRED FOR YOUR STATE FOR THIS PERMIT.

**11. RULE OF SIFTING: THE SALE MANAGERS RESERVE THE RIGHT TO BAR ANY ANIMAL FROM SELLING THROUGH THE REGULAR SALE, WHICH MIGHT LIMIT THEIR USEFULNESS AND LATER BECOME A SOURCE OF CONTENTION. AN EXAMINATION OF EACH ANIMAL WILL BE MADE BY A COMPETENT, EXPERIENCED COMMITTEE OF THREE OR MORE WELL-QUALIFIED PERSONS IMMEDIATELY PRECEDING GRADING. ALL ANIMALS BARRED FROM SELLING THROUGH THE RING FOR REASONS MENTIONED ABOVE CAN BE SOLD AT AUCTION THE NEXT REGULAR SALE DAY, WHICH IS THE FOLLOWING THURSDAY, SOLD AT PRIVATE TREATY OR TAKEN HOME. PRIVATE TREATY SALE OF SIFTED ANIMALS MUST BE MADE THROUGH THE SALE MANAGEMENT.**

**12. REGISTERED BULLS CANNOT AND WILL NOT BE CATALOGED AS SUCH WITHOUT COPIES OF, OR THE ORIGINAL REGISTRATION PAPERS BEING RECEIVED BY FEBRUARY 3, 2023. SIGNED REGISTRATION PAPERS (TRANSFER FORMS) MUST BE IN THE OFFICE ON SALE DAY BEFORE THE SALE BEGINS.**
